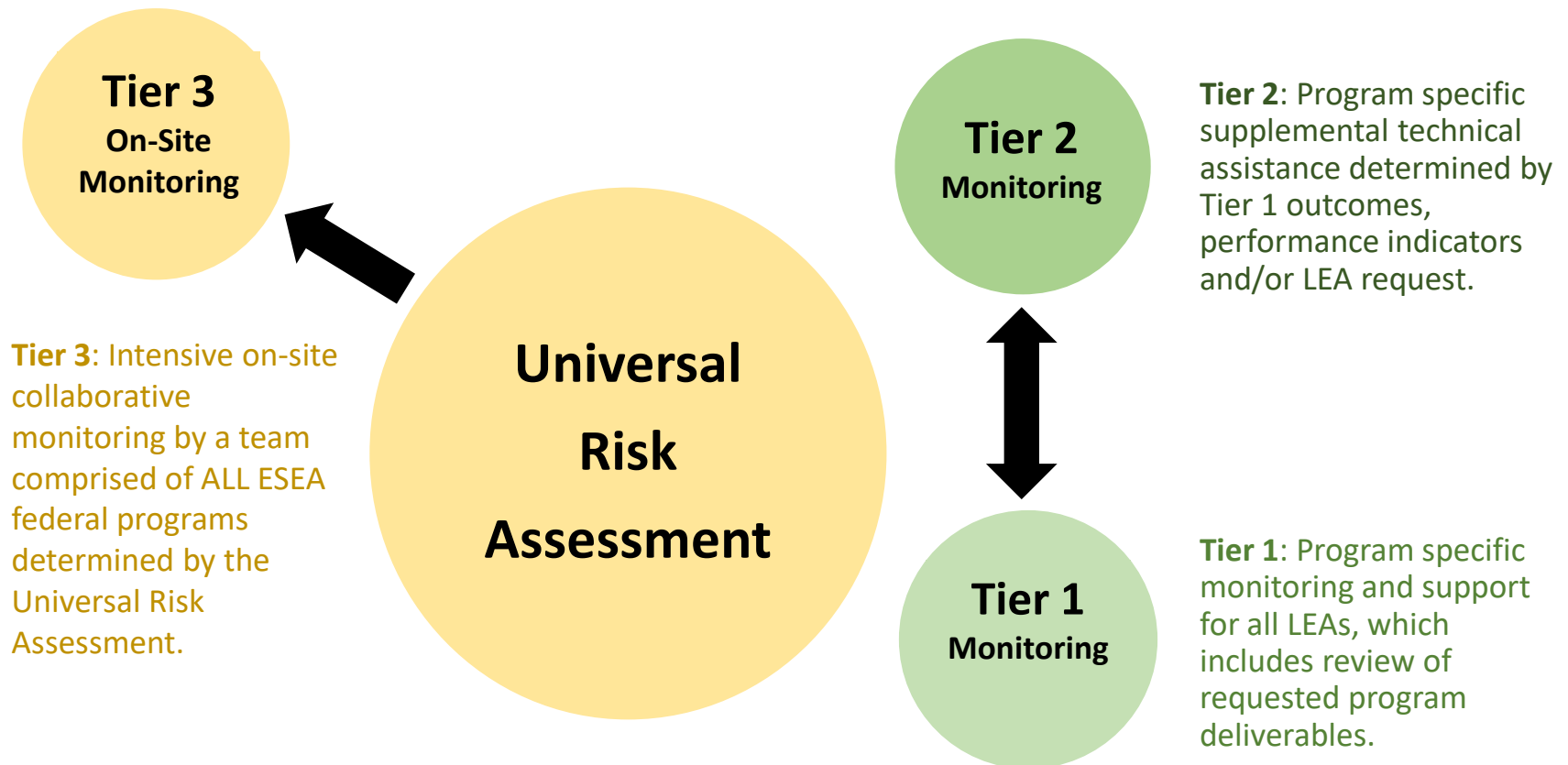

# Migrant Student Records Transfer

Migratory children make frequent moves between school districts and between states, which can cause gaps in their educational records.

Local Educational Agencies receiving Title I, Part C funds are required to address this issue through:

- Facilitating the timely transfer of migrant student records between school districts and other states; and
- Transmitting migrant student data to the national Migrant Student Information Exchange (MSIX).

# Migrant Student Information Exchange (MSIX)

According to the United States Office of Migrant Education, the purpose of MSIX is to:

- Ensure continuity of educational services for migrant children by providing a way for states to exchange educational information on migrant children.
- Improve the timeliness of school enrollments.
- Improve the appropriateness of grade and course placements.
- Facilitate the accrual of course credits by providing accurate academic course history.
- Notify states and districts of migrant students moving to/from their area.

# March Uploads

## Migrant Student Records Transfer

1. The Local Educational Agency (LEA) shall promote interstate and intrastate coordination of services and ensure educational continuity by reporting comprehensive and accurate academic and health information for migratory children in a timely manner via the local and state student databases when children move from one school district to another, whether or not such move occurs during the regular school year.
  - 1a. Evidence of LEA transmitting migrant student records to MSIX and responding to MSIX worklist items according to MSIX timeframes (example: Management Information System (MIS) generated MSIX transmission report).
  - 1b. Written LEA MSIX processes and procedures.

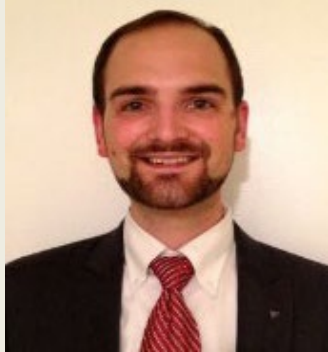
